Online Privacy Policy

Arizona Investors Alliance, LLC. (“Arizona Investors Alliance”) respects the privacy of every individual and is strongly committed to respecting and protecting your privacy. Please carefully read the following Privacy Policy.

This policy applies to any person, corporation, partnerships, company, or other entity (“You, Your, Yours, or User”) accessing, browsing, or otherwise using this website located at www.BIDAZForeclosures.com (the “Website”). This Policy had been drafted to explain the type of information that Arizona Investors Alliance collects from our Users, the use of that information by Arizona Investors Alliance and any extenuating circumstances surrounding the use of that information. User Consent to Privacy Policy

By accessing, browsing or using the Website, Users acknowledge that they have read, understand, agree, and consent to the terms and conditions of the Policy. Users consent to the collection, use, and disclosure of User information including personal information and anonymous browsing information (together “Information” according to the terms of this Policy). This Information Arizona Investors Alliance Collects

- Anonymous Browsing Information

Arizona Investors Alliance uses the information provided by the web visitor to improve the quality and usefulness of its Website. Arizona Investors Alliance gathers some generic information such as Internet Protocol address, your computer’s operating system, the name of the domain you uses to access the Internet, and the website you came from and are visiting next. This information does not reveal your identity of a visitor, and usually logs the number and frequency of visitors and the Arizona Investors Alliance page visited, etc. Arizona Investors Alliance does not combine information collected in this way with any personally-identifiable information.

- Personal Information

otherwise. By submitting information to this Website, Users acknowledge that they have read this Policy, understand it, agree to its terms, and authorize Arizona Investors Alliance to collect, use, and disclose Information pursuant to the terms of this Policy.

How Your Information is Used

This information that Arizona Investors Alliance collects and maintains is known under the FCC (Federal Communications Commission) as Customer Proprietary Network Information (CPNI).

Arizona Investors Alliance uses the Information or CPNI collected from its Users to respond to Users' questions, comments, or to provide services to Users. Anonymous browsing information may be used to gather broad demographic information used in marketing, promotion, or similar activities. This information may be aggregated to measure the number of visits, average time spent, page views, and other statistics about Users of the Website. Arizona Investors Alliance also may use this data to monitor Website performance and to make the Website easier and more convenient to use.

How your information is Shared

Arizona Investors Alliance will not sell, share, trade, or give away any Information that it collects or receives regarding its Users subject to the following exceptions:

- If Arizona Investors Alliance has a User's consent to share personal information
- Arizona Investors Alliance may use statistics about its User's website activity for purposes of marketing, promotion, or similar activities
- Arizona Investors Alliance may disclose Information about its Users to others if it has good faith belief that it is required or permitted to do so by law or legal process, to respond to claims, or to protect the rights, property, or safety of Arizona Investors Alliance or others.

Applicable Law/ International Users

Information that is submitted to this Website will be collected, processed, stored, disclosed, and disposed of in accordance with applicable U.S. law. If you are a non-U.S. User, you acknowledge and agree that Arizona Investors Alliance may collect and use your Information and disclose it to other entities outside your resident jurisdiction, as discussed in "How your information is shared" above. In addition, such Information may be stored on servers located outside your resident jurisdiction. U.S. law may not provide the degree of protection for personal information that is available in other countries.
